EXPRESSION OF INTEREST (EOI): V/UHF MAN - PACK SDR (MAKE-II)

The objective of this invitation of Expression of Interest (EoI) is to seek willingness of Indian Vendors to participate in the Make-II Project listed below, in accordance with provisions of DPP-2016 (reference Chapter III-A as amended). Indian Vendors meeting the Technical, Commercial and Project Requirements laid out in the EoI and as per DPP-2016 (reference Chapter III-A as amended) will be, as the next step, issued a 'Project Sanction Order' to develop a prototype on NCNC basis.

Project Basic Information

- 1. Nomenclature. V/UHF Man Pack SDR (Make II)
- Sponsor Directorate. DG Signals (Signals 5).
- Brief Description and Operation Reliable, robust and responsive communication is a vital and critical part of any military operation and plan. The Combat Net Radio (CNR) is the mainstay of tactical communications at the forward edge of the battlefield at Formation, Unit and Subunit levels. The contemporary CNR equipment in the Indian Army supports voice communication only and has limited or no data transmission capability. To arm the soldier with advantages offered by technology and equip him to fight a war in the Net - Centric battle space, it is necessary to provide network capable tactical equipment and connect him to the Digital Data Network. It is thus proposed to procure V/UHF Man - Pack Software Defined Radio, to be designed and produced to meet the requirements of PSQR (relevant instructions attached at Appendix A). The proposed system should have the ability to establish communication, both in clear and secure mode and in fixed frequency and frequency hopping modes. It should be operable in the frequency range of 30 - 512 MHz, to be able to transmit voice, data, message and video.

Categorisation.

- (a) Prototype Development Phase. Make–II (Industry Funded) in accordance with Para 6, Chapter–III A of DPP 2016 (as amended).
- (b) <u>Procurement Phase</u>. Buy (Indian–IDDM) with minimum 40% indigenous content in accordance with Para 5 of Chapter–IIIA of DPP 2016 (as amended).
- 5. Quantities Required (Including Ancillary Equipment and Accessories).
 - (a) <u>Prototypes for the Development and Trial Stage.</u>
 Respondents to this EoI will furnish quantity 32 sets of V/UHF Man-

Pack SDR, complete with all ancillary equipment and accessories as given in the PSQR. This equipment will be required for all trials and evaluations and will be fielded therein. All trials will be carried out on No Cost No Commitment (NCNC) basis.

- (b) Finished Equipment Manufactured to the Final GSQR. Post successful User Trial Readiness Review (UTRR), the PSQR will be frozen and Commercial RFP will be issued. Post issue of Commercial RFP, the equipment will be trial evaluated as per detailed Trial Directive. The Trial Directive will be provided to successful vendors once the PSQR is frozen and converted into GSQR. The instant case is for procurement of quantity 600 sets of V/UHF Man-Pack SDR, complete with all ancillary equipment and accessories which will be supplied in one lot.
- 6. <u>Timelines</u>. The timelines are given at **Appendix B** to this Eol.
 - (a) <u>Upto Prototype Development</u>. The final prototype, developed by the manufacturer to the requirements of the PSQR will be provided to the IA for conduct of UTRR not later than 18 Months from the date of placing of Project Sanction Order.
 - (b) <u>Development and Porting of Waveforms</u>.
 - (i) Post successful development of the prototype and ratification of GSQR, the manufacturers will be required to make interoperable waveforms for legacy radio sets held with the Indian Army and for the SDR being procured by the Indian Army through the Design and Development Route.
 - (ii) The manufacturers will be facilitated with technical, design and waveform data of In-Service legacy radio sets of the Indian Army and the SDR being procured from the Design and Development (Under Para 72 of Chapter II of DPP 2016) route. This data of the SDR being developed based on this EoI also to be shared by the DAs and the Production Agency for the SDR through Design and Development (under Para 72 of Chapter II of DPP 2016).
 - (iii) These interoperability waveforms to be developed within three months of receiving the technical, design and waveform data from the Production Agency for the concurrently developed SDR (Design and Development under Para 72 of Chapter II of DPP 2016) facilitated by the Indian Army.

(c) For Production of Quantity 600 of Equipment Pieces. The fully developed equipment will be supplied by the manufacturer within 12 Months from the date of placing of Contract in a single lot.

Additional Important Aspects

7. <u>Security</u>. The V/UHF Man – Pack SDR being procured through the Make II Sub Category of DPP 2016 shall have an insertable / slot based Hardware Security Module (SM) devoid of Cryptographic Algorithm, which shall support the capability to load an external Cryptographic Algorithm / Software developed by nominated Design Agency (Security Subsystem), or DA – SS.

Interoperability and Compatibility

- 8. A separate project is under progress for development of V/UHF Man Pack SDR through the Design and Development Route as per provisions of Paragraph 72 of Chapter II of DPP 2016. This SDR will also meet the requirements of the same PSQR as that of the V/UHF Man Pack SDR being procured through the instant case. The PSQR for V/UHF Man-Pack SDR (Make -II) will be provided separately to the respondents of this EoI on signing of Confidentiality Agreement.
- 9. The respondents to this EoI will be required to make the V/UHF Man-Pack SDR (Make-II) interoperable with the SDR being procured through the Design and Development route as per provisions of Paragraph 72 of Chapter II of DPP 2016. It has also been separately mandated that the agency designing and developing the V/UHF Man-Pack SDR (Design and Development as per provisions of Paragraph 72 of Chapter II of DPP 2016) will make their system interoperable with the V/UHF Man-Pack SDR (Make-II).
- 10. On successful development and conclusion of UTRR of the prototype, the PSQR will be frozen and converted to GSQR. At this stage, the manufacturer will provide technical, design and waveform data of his prototype to the Production Agency of the SDR (Design and Development as per provisions of Paragraph 72 of Chapter II of DPP 2016) for development of compatible waveforms.
- 11. At this stage, the manufacturer will also be facilitated with technical, design and waveform data of legacy, in service radio sets of the Indian Army and of the SDR (Design and Development as per provisions of Paragraph 72 of Chapter II of DPP 2016) by the Indian Army and the Production Agency

respectively. The manufacturer will use this data to develop waveform / waveforms for SDR developed by him in order to make it compatible with legacy In Service radio sets of the Indian Army and the SDR (Design and Development as per provisions of Paragraph 72 of Chapter II of DPP 2016).

- 12. <u>Intellectual Property Rights (IPR)</u>. The Intellectual Property Rights (IPR) of the SDR, including but not limited to design, data, hardware, software and waveforms will be the property of the Government of India as per provisions of Para 47 of Chapter III A of DPP 2016 (as amended).
- 13. <u>Minimum Indigenous Content (IC) Required</u>. The equipment that is finally supplied by the manufacturer to the Indian Army will comprise a minimum of 40 percent IC on cost basis.


