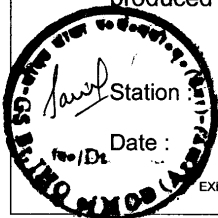

The requirement of communications during hostilities, natural disasters and other unforeseen contingencies is equally critical, especially for formations and units deployed beyond Line of Sight (LoS) communication ranges. High Frequency (HF) radio communication is a tried and tested technique for reliable, long distance radio communication. It is thus proposed to procure HF Manpack Software Defined Radio (SDR), to be designed and produced to meet the requirements of PSQR.

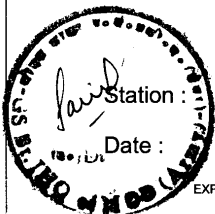
2. The objective of this invitation of Expression of Interest (Eoi) is to seek responses from eligible Indian Vendors for the development of prototype and further procurement of HF Manpack SDR.

HF Manpack Software Defined Radio (SDR)

9. **Scope.** The HF Manpack SDR is envisaged to provide communication at beyond Line of Sight (LoS) communication ranges. The proposed system should have the ability to establish communication, both in clear and secure mode and in fixed frequency and frequency hopping modes. It should be operable in the frequency range of 1.5 - 30 MHz, to be able to transmit voice, data, message and video.

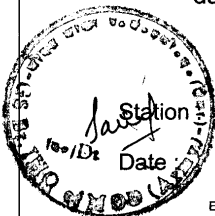

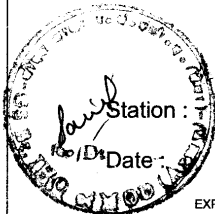

Additional Important Aspects

12. **Security.** The HF Manpack SDR shall have an insertable / slot based Hardware Security Module (SM) as per PSQR to be developed in consultation Development Agency Security Sub Systems (DS-SS) details of the same will be given at PSO Stage.

13. **Intellectual Property Rights (IPR).** The Intellectual Property Rights (IPR) of the SDR, including but not limited to design, data, hardware, software and waveforms will be governed by the provisions of Para 59 of Chapter III of DAP 2020 and amendments thereof.

Development of Prototype and Trials

14. All possible and reasonable assistance and any clarification related to functional or operational aspect of development as sought by DAs will be provided to respective DAs by Project Facilitation Team (PFT).

15. After the prototype has been developed as per PSQR given at **Appendix A**, the PFT would conduct Prototype Readiness as per Chapter III of DAP 2020 and amendments thereof (as applicable). Service HQ will formulate the 'Trial Directive' which will incorporate the parameters for validating the 'Essential Parameters'. Necessary technical literature pertaining to the design & material will be provided by the DAs for conduct of Prototype Readiness to ensure matching of prototype specification with PSQR as per Chapter III of DAP 2020 and amendments thereof (as applicable).

Solicitation of Commercial Offers

16. A commercial Request for Proposal (RFP) for 'Buy (Indian-IDDM)' phase would be issued to DA(s) as per DAP 2020 and amendments thereof (as applicable) for soliciting their commercial offers.

21. **Indigenous Content (IC).** Indigenous Content minimum 50% is to be achieved. Post successful development under Make-II would result in acquisition from successful DAs through 'Buy (Indian-IDDM)' category with indigenous design and development. The Indigenous Content >50% in accordance to Para 21, Chapter I of DAP 2020.
